- 4. Pre-bid meeting shall be held at 12:15 pm, 2080/01/21 at Gautam Buddha International Airport Aerosynoptic Station, Bhairahawa, Rupandehi.
- 5. Electronic bids must be submitted to the PPMO's e-GP system www.bolpatra.gov.np/egp on or before *12:00PM* on *2080/02/03*. Bids received after this deadline will be rejected.
- 6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 12:15 pm on 2080/02/03 at the office of Gautam Buddha International Airport Aero-synoptic Station, Bhairahawa, Rupandehi. Bids must be valid for a period of 90 days from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs.60,000 (sixty Thousand Only), which shall be valid for 30 days beyond the validity period of the bid (i.e.2080/06/03).
- 7. If the last date submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the **bid and** bid security shall remain the same as specified for the original last date of bid submission.
